Informed Consent

This document is to inform you of my background and to ensure you understand the nature of our counseling relationship. Bree Winkler is a Licensed Professional Counselor in Georgia and has practiced since 2009. I have been certified as a School Counselor since 2004 and have a certification in Anger Management. I hold a Specialist in Education and Masters in Education in School Counseling from Georgia State University.

Although our sessions (8-12) may be very intimate and challenging, it is important for you to complete all sessions to gain maximum benefits. However, you or I may terminate session(s) any time we feel your needs are not met. I will keep confidential anything you share with me, with the following exceptions: (1) you direct me in writing to tell someone else, (2) I determine you are a danger to yourself or others, or (3) I am ordered by a court to disclose information. If, at any time and for any reason, you are dissatisfied with my services, please let me know. If I am not able to resolve your concerns, you may report complaints to the State of Georgia Board for Professional Counselors.

In the return for a fee of \$95/session (in addition to the one-time \$35 online Assessment fee/Couple), I agree to provide pre-marital and/or marriage professional counseling services to you and your partner. Sessions are 50 minutes in duration. Session fees must be paid at the time of service. If you cannot keep an appointment, you must notify me 24 hours in advance; otherwise, you will be responsible for missed sessions by paying the entire session fee. Couples counseling is not covered by insurance. I accept cash, check, or credit card (\$3/transaction fee for cc) for payment.
